Instructions and Checklist for Completing Scholarship Application

Building a Workforce

The Home Builders Association of Greater Kansas City (KCHBA) is a nonprofit that serves as the voice of the housing industry. Comprising of approximately 500 member companies, the HBA represents an industry that contributes more than \$1.5 billion to the Kansas City economy and supports more than 20,000 jobs in the Greater Kansas City metropolitan area.

KCHBA actively promotes employment opportunities for young people interested in construction trades and supports students pursuing a career in the residential construction industry. \$500 scholarships will be awarded by the Home Builders Association of Greater Kansas City (KCHBA) to deserving high school seniors, or equivalent.

Students that are awarded the "Career Ready" scholarship will need to be accompanied by a representative from the student's educational institution and a KCHBA workforce development committee member to a retail center to secure their tools/supplies for their new career. The tools and supply list will be based upon the applicant's chosen field and the applicant will not be awarded until proof of employment is provided.

Eligibility Criteria

1. The applicant must be a high school senior or equivalent.
2. Provide proof of a confirmed position with a construction related business no later than July 26, 2024.

Application Requirements

The attached scholarship application must be completed by the student and must be post marked no later than April 19, 2024. Incomplete applications will not be considered. Below is a list of all the necessary requirements:
